Dear Mr. Sawkiewicz:

An inspector with the Indiana Department of Environmental Management (IDEM), Underground Storage Tank (UST) Section, will be conducting an inspection at the facility listed above within the next 30-45 days.

To prepare for the upcoming inspection, all compliance paperwork must be submitted to IDEM within fifteen (15) days of your receipt of this letter. In accordance with 329 IAC 9-3-1(a), the owner and operator of an UST system must cooperate fully with inspections, as well as requests for document submissions.

This compliance paperwork may include, but is not limited to, the following:

- The last 12 months of release detection records for tanks and piping, to include results from required interstitial monitoring
- The most recent line tightness test if it is only performed every three years
- Any automatic tank gauge inspection, calibration or repair documents
- Results of the last two corrosion protection evaluations for tanks and/or piping
- Any line tightness, tank tightness, and leak detector test results from the last 12 months
- Operator training certificates
- The most recent internal liner inspection reports with video, if performed
- Documentation of any repairs made to the UST system, including an internal liner, during the last 36 months
- Work orders for scheduled repairs
- Certification of financial responsibility
- Notification form, if not submitted and approved since January 1, 2014
